Fredric R. Jameson is Knut Schmidt-Nielsen Professor of Comparative Literature, Professor of Romance Studies (French), and Director of the Institute for Critical Theory at Duke University. He is the author of many books, including Marxism and Form (1971). The Political Unconscious (1981) and Postmodernism, or, The Cultural Logic of Late Capitalism (1991, recipient of the MLA Lowell Award). His more recent works include The Antinomies of Realism (2013. recipient of the Truman Capote Award), The Ancients and the Postmoderns (2015), and An American Utopia: Dual Power and the Universal Army (2016). Jameson received the 2008 Holberg International Prize and the 2012 MLA LifeTime Achievement Award for his scholarship.

Adrian Johnston is a Professor in the Department of Philosophy at the University of New Mexico at Albuquerque and a faculty member at the Emory Psychoanalytic Institute in Atlanta.
